It is not designed to "replace" your business plan (which may already have been written, used and circulated to other potential investors) but to augment it by providing the answers to key questions that investors are interested in. These questions have been well researched in the investment community, therefore, we believe that it is important for you to answer them if you want the best investor response to your plan. While we cannot possibly guess the answers that appeal to each individual investor, you can assure that we have covered the greatest possible range of investor interests. Some of the questions enable us to match your plan and expectations to our investor profiles (giving you the greatest possible coverage with the least amount of time/writing), some provide the context of your plan, some enable you to express your expectations about an investment and some enable the investor to quickly assess their possible interest in your full business plan.

You may have already answered many of our questions somewhere in your Business Plan - if so all you need to do is to summarise the information and cut and paste it into the Investment Summary. Other questions may not have been answered in your Plan and we ask you, therefore, to consider them here for the first time. You do not have to complete the Investment Summary in one session, therefore, take your time in considering your answers. We have provided explanations for each question. Your Investment Summary will not be published, until you have decided that you are satisfied with the range of answers you have given.
